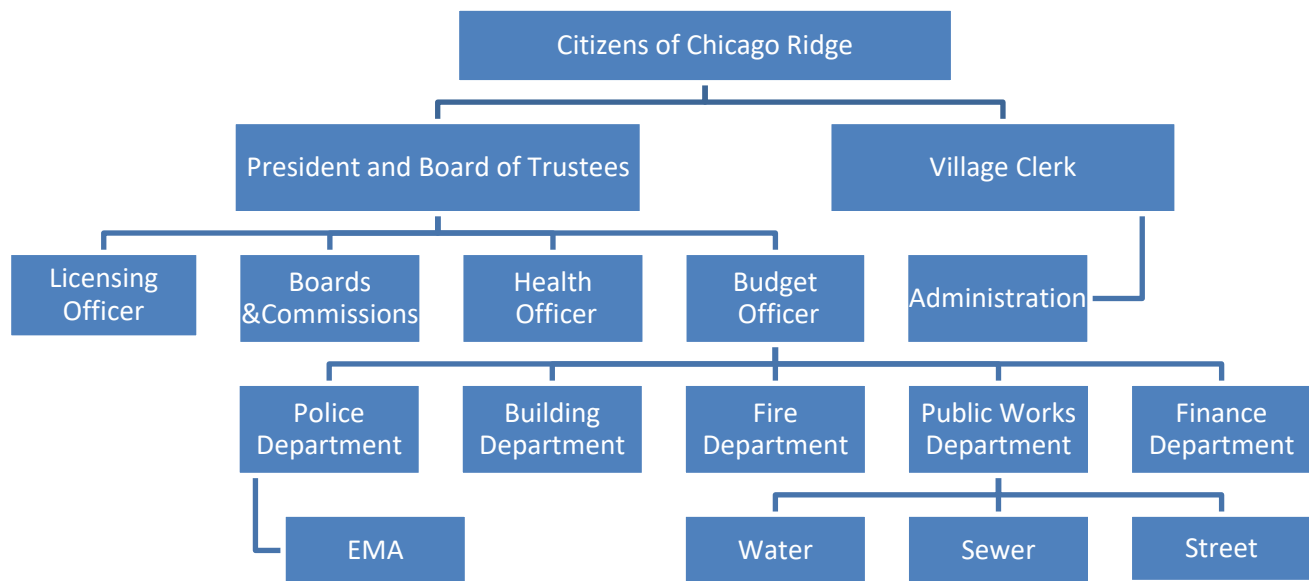

Copying charges are 15 cents per page thereafter. Additional charges may be imposed for large format or certain electronic media copies, or color copies, if available. Waivers of these charges may be available per the Freedom of Information Act.
